Some things you need to know about Internet Cookies

Cookies are small text files placed on your device to store data that can be recalled by a web server in the domain that placed the cookie. This data often consists of a string of numbers and letters that uniquely identifies your computer, but it can contain other information as well. We use cookies to store and honour your preferences and settings, enable you to sign into our online access service, combat fraud and fulfil other legitimate purposes described below:

Our use of cookies

They are essential to the effective operation of our website and to make your experience natural. They concern the way the website functions and gives you a better browsing experience by memorizing the information and data you inputted to facilitate your access to reserved or personal spaces. Cookies help to personalize the content of the site, offering you the best browsing experience possible whenever you visit our website. Veritas Registrars uses cookies and similar technologies for several purposes, depending on the context, including:

- **Storing your preferences and settings.** We use cookies to store your preferences and settings on your device, and to enhance your experiences.
- **Sign-in and authentication.** We use cookies to authenticate you. When you sign into our website using your personal information, we store the information in an encrypted cookie on your device. This cookie allows you to navigate from one page to another within the site to another without having to sign in again on each page. You can also save your sign-in information, so you don't have to sign in each time you return to the online access page.
- **Security.** We use cookies to process information that help to secure our products and services as well as detect fraud and abuse.
- **Storing information, you provided to our website.** We use cookies to remember information you shared. When you provide information via the online access, we store the data in cookie for the purpose of remembering the information.
- **Feedback.** Veritas Registrars uses cookies to enable you to provide feedback on our website.

Types of cookies we use on this web site

Functionality cookies: These cookies allow us to provide you with enhanced features that need to remember your preferences and choices.

Performance cookies: These cookies help us monitor and improve how our website works by collecting information when you visit our website. They also help us monitor how our website is performing so we can keep on improving on it. The retention period for these cookies is dependent on the expiration-date set by the browser.

Cookies facilitating online communication: They aim to remember the data entered by you on the website.

How you can control cookies

Most web browsers automatically accept cookies but provide controls that allow you to block or delete them. For example, in Microsoft Edge, you can block or delete cookies by selecting **Settings > Privacy and services > Clear Browsing Data > Cookies and other site data**. In Google Chrome, you can block or delete cookies by selecting **Settings > Privacy and security > Clear browsing data > Clear history, cookies, cache and more**. If you use a different browser, refer to the browser's instructions.

Certain features depend on cookies. If you choose to block cookies, you cannot sign in or use some of these features, and preferences that are dependent on cookies will be lost. If you choose to delete cookies, any settings and preferences controlled by those cookies are deleted and will need to be recreated.
